NOTICE OF ELECTION

In conformance with its Constitution and Bylaws, as well as the Labor Management Reporting and Disclosure Act of 1959, and the Constitution of the IATSE, notice is hereby given that Affiliated Property Craftspersons, Local 44, IATSE, will be conducting its triennial election for officers during the months of March and April, 2007. Pursuant to Article IX of the Local's Constitution & Bylaws, the election process will be overseen by the Local 44 Election Committee.

The offices subject to this election are: President, Vice-President, Business Agent, Secretary-Treasurer, Sergeant-At-Arms, 2 Representatives from 4 Crafts (Coordinators, Prop Masters, Set Decorators, and Special Effects), and 3 Representatives from the other two Crafts (Property and Propmaker). There are 3 Trustee positions available and one Delegate for Conventions of the International from each of the 6 Crafts.

Also, in this election, there are 12 new positions to run for (as approved in the new Article 9). They are Alternate positions. There is an Alternate for each of the Craft Representative categories, and six Alternate Delegate positions for each of the six Delegate positions. An Alternate Rep may attend Board meetings, but has no vote or voice, unless one of the elected Representatives in his Craft is absent from a meeting. At this point the Alternate steps up to the table and conducts business for the original Rep. He steps down at the end of each meeting and reassumes his Alternate Delegate only serves if the original Delegate is unable to attend an International or District Convention due to some other commitment. These positions were voted in to ensure that a full Board and a full compliment of Delegates would be available at all times to represent the members.

After the petitions are returned to the locked box at Local 44's offices, it is up to the Election Committee to determine if a candidate is eligible to run, and whether they have enough legitimate signatures to place them on the ballot. Please do not ask office staff to help you determine this; they are not allowed to answer these questions.

The Election Committee is in charge of finding a Election Service Provider, securing a post office box for return ballots, working with the Balloting Service to create the ballots, cover letters and return envelopes. The Committee also receives all mailing literature from candidates, ensures that the proper mailing lists are sent to the Mailing House, and delivers the mailings to the Mail Service Provider.

The Committee will be in place to determine any objections, challenges or protests that arise throughout the campaign.

The primary election ballots will be mailed by March 15th and must be received in the secured post office box selected by the Election Committee no later than 10:00am on March 30, 2007. The ballots will be sent to the membership by the Election Service Provider and a separate instruction sheet will be included with the ballots.

The Election Committee shall oversee the counting of the ballots by the Election

Service Provider and each candidate may have one previously designated observer to ensure fairness in the counting process.

If no candidate wins the election outright in the primary (they must receive 50% + one vote of all qualified votes cast), then there will be a run-off round for those contested positions. The top vote-getters in each contest are in the run-off. If there is one spot available, the top two candidates run; if there is more than one spot open (e.g. there are 3 Trustee spots and no one gets a majority), then one more candidate than positions open are in the run-off (in this case 4).

Ballots for the run-off election, if any, will bee mailed on April 10, 2007, and must be received at the post office no later than 10:00am on April 30, 2007. If a run-off for any elected office is required, these ballots will also be sent to the membership by the Election Service Provider and a separate instruction sheet will be included with the ballots.

A special Executive Board meeting will be called on June 6, 2007, to install all elected officials whether they won in the primary or the run-off election.

Please consult the newly adopted changes to Article IX of Local 44's Bylaws for additional information about the election process. Copies of the newly adopted Article IX are available at the Local's Business Office.

Section One – At-Large Candidates

The following grouping of candidates are voted on by the membership as a whole. Each member votes in each of the following categories of candidates.

Business Agent Secretary-Treasurer President Vice-President Trustee Sergeant At Arms

The Business Agent and the Secretary-Treasurer are the paid positions of the Local and are responsible for the day-to-day legal and financial care of the Union. Both positions are automatically Delegates to all International conventions.

The President and Vice-President are the chairpersons of the Local. They moderate all general meetings, and Executive Board meetings, and the President is automatically on all Committees. The President is also automatically a Delegate to all International conventions. The Vice-President assumes all duties of the President when the President is absent.

The Trustees are the first-line of financial oversight for the Local. They inspect the books of the Local quarterly to insure they are done properly, and currently are also responsible for contracting with an independent accounting firm for the yearly audit. Each member is allowed to vote for 3 candidates in this category.

The Sergeant-At-Arms is the Officer assigned to maintaining decorum at all meetings. Additionally, though not a member or participant of the Executive Board, the Sergeant At Arms attends all Executive Board meetings and is responsible for maintaining and distributing all literature.

For the most part Candidates were listed alphabetically. For formatting purposes there may be an instance or two where that is not the case.





Section Two – Representatives of the Craft

The following groupings of candidates are voted on by the members involved in their respective Crafts. Each member will have multiple votes for their Craft Representatives depending on the Craft involved and will have an additional single vote for the new Representative Alternate. The following is a list of the Craft Representative positions and the number of votes each member may cast:

Coordinator Representative (2 votes) Property Representative (3 votes) Property Master Representative (2 votes) Propmaker Representative (2 votes) Set Decorator Representative (2 votes) Special Effects Representative (2 votes)

Additionally, each of the above 6 Crafts has a Representative Alternate. **Members vote for one Alternate from their respective Craft.**

The Representatives are the members' direct conduit to the lawmaking and oversight of the Local and serve on the Executive Board. The Executive Board is the legal body of the Local and one of the checks and balances of our Constitution. They help create and apply our laws, and on behalf of their members make concerns and desires known to the direct legal agent (the Business Agent) and the financial agent (the Secretary-Treasurer) of the Local. Representatives direct the Local and make decisions on behalf of their members and have a high fiduciary responsibility; on occasion they may be privileged to sensitive legal material or situations which they cannot reveal to the membership until the resolution of the situation.

The Representative Alternates are new positions, and this is the first time they are elected since the creation of the position in our newly adopted Election Article was approved. Alternates sit in on all Executive Board meetings as observers, but are not allowed to voice or vote on any issues. This changes if the regular Representative is absent from the meeting. At this point the Alternate moves to the Executive Board table and participates and votes just like any other member. As the Alternate has been privileged to hear all issues and the history up to that point, there is no need to "bring them up to speed". The Alternate steps back from the table and reverts back to his Alternate position when the regular Representative returns.



Delegates may be assigned to committees that rule and bring their recommendations to the larger delegation to vote on. Delegates may attend seminars presented at conventions. A Local 44 Delegate is called on to assemble once a year for a District 2 convention and once every 4 years for an International convention.

By virtue of their positions 3 Officers of the whole are also Delegates; they are President, Business Agent, and Secretary-Treasurer.

The Delegate Alternates are new positions, and this is the first time they are elected since the creation of the position in our newly adopted Election Article was approved. Alternates attend any convention at which the regular elected Delegate for that Craft is unable to attend.




