Local 44 Run-Off Results

Local 44 IATSE had two contested positions after the first-round of elections concluded, causing a run-off in these two races. They were for the Sergeant-At-Arms and for the third Propmaker Representative position.

In the battle of Dan versus Dan, you had two former Sergeant-At-Arms running for re-election. Dan Boone, a descendent of "the" Dan Boone of frontier fame, held Sergeant-At-Arms from 2001-2004. Dan Graham held the position 3 years prior, from 1998-2001. Dan Graham is also a current Callboard Steward and has recently taken on the duties of collections and death benefits at the Hall.

The Propmaker race pitted newcomer Tony Chavez versus appointed incumbent Leonard Martin. Tony Chavez made his first run in the political arena, though he has been a Shop Steward and therefore involved with the Local since 2004. Leonard Martin was elected by the Executive Board to replace Gene Owens who resigned from his position in the middle of 2006. Leonard Martin had run for office before, but hadn't been

Meet Your Assistant B.A.'s

It's not unusual for members to be unfamiliar with the government of their own Local. If the Governor of California hadn't had his face in movies over the years, it's unlikely half the people in the State could identify him.

Many members don't know the extensive procedures of the Executive Board, and in many cases, even who their Executive Boards Representatives are. If you haven't had a need to come to the office or go to an event, you most likely couldn't identify your Secretary-Treasurer, your callboard Stewards or the Business office staff. These are persons

that work internally under the Secretary-Treasurer and rarely get out into the field.

Your Business Agents are a much different story. They are more visible to the membership simply because you see them in the field. When you need help with a problem, whether it's a safety issue, or over local jurisdictions, or even payroll related, these are the guys who show up. They're your advocates in the field; they are the enforcers of contracts.

When you voted for the Business Agent, you also voted for his Assistant Business Agents. That having been said, in order for you to be more knowledgeable of who that guy is walking up to you on the set, shaking your hand and introducing himself; we'd like to provide that introduction to you in advance.

There are now three Assistant Business Agents working under newly-elected Business Agent Ed Brown. Paul Ahrens and Carl Hicks have been working with BA Brown for over a year. Anthony Pawluc, a long-time Local 44 staffer and member, was just approved by the Executive Board in April to become the third Assistant B.A.

Business Agent's Report

Get in the Boat

When George Washington stood on the shores of the Delaware he offered up to his crew a simplistic and direct statement. As he himself entered the small vessel he turned to his crew and said, "Get in the boat!" Without that directive who knows how many trusty soldiers would have been left behind and to what tale history would tell. As we continue to move beyond the trappings of the past and build a solid future, we can definitely use a full crew. Your participation is needed to row this boat. After reviewing the participation numbers from both our election and recent membership meeting, it's obvious we need more hands on deck. From the response of those in attendance at that meeting, it was evident that the questionable campaign tactics from our election turned off many members from voting and from meeting attendance. Let me assure you, this is not the same organization you have become accustomed to. This administration is moving forward, addressing issues and building relationships by progressing one step at a time. We are creating a union you can say you are proud to be a part of. There will always be those that are bent on tearing down and dividing for self centered purposes, don't give them a platform or your support. Don't let negativity and destructive tactics take hold of you and prohibit your participation, vote when given the opportunity, attend when required, participate, grab an oar and, "Get in the Boat!"

Using Non-Union/Non-IA Fabricators

Month after month we publish a list in the Newsreel of what is to the best of our knowledge non-signatory facilities. We continue to state that usage of these or other non-union shops may result in appropriate action. Let's get down to the facts. The Producers are contractually bound by the Basic Agreement to "protect and preserve the work opportunities available to employees covered by this Agreement who have traditionally and historically performed the work covered by the classifications and job duties set forth in this Agreement." Or notify both the local union and the International when requesting to sub-contract work not traditionally covered by this agreement. When you take that work to a noncovered (non-union) shop you are aiding the break down of those contracts. What does this really mean and how does it affect you? Well for every worker performing this work there is one Local 44 member who didn't get that job, who didn't get the hours contributed to their pension or health coverage. Who's to say that person couldn't be you? This must stop. As we continue to work towards keeping film and television production here in California, the same fight should be waged to keep our work under our union banner. We will be stepping up our enforcement of illegal sub-contracting and usage of non-signatory shops. Don't get yourself caught in the middle of one of these investigations. You could be the subject of internal charges and your Producer the target of a grievance. We maintain a list of Signator shops and facilities on the web site, check this list to make sure you are using a union shop, or if your even the slightest bit unsure, call us we will get you the list. This is all part of working together and protecting each others livelihoods.

Report your work

I cannot stress as well how important it is to let us know where you are working, and what project you are working on. I have already stated previously all of the safety reasons, database reasons and so

on. But going further, if you are working on a non-union/non-IA project and don't pick up the phone, you are in direct violation of your obligation as a member of this local and the International. By not reporting this work you are as well undermining Trade Unionism and supporting sub par working conditions and lack of pension and health benefits to hard working brothers and sisters. Let us know where you are and what you are working on, this part of protecting each other is vital.

P.A.s doing our work!

This trend is increasing and must be stopped in its tracks. We are finding this happening in the Property craft mostly, where P.A.'s are running errands, doing small shopping tasks and acting as assistant's. As well we have had instances of using P.A.s to move Greens, operate elevator doors and E fans. The producers know this is a violation and when we have caught them they have readily corrected the issue. If you are aware of any of this going on in any form, this is the time to pick up the phone. P.A.s cannot and will not be allowed to do any IA covered work. This office will file as many grievances as it takes to stop this trend and we need and expect the cooperation of the membership. Remember, this will protect your jobs and our jurisdiction.

Be Prepared!

In closing, again I must caution you that there has been no progress in the pending WGA, SAG contract discussions. We are looking at what could be a very unpredictable twelve months ahead or more. Do what you can to prepare yourself for the worst, and let's hope for the best

Take Control "Death" Insurance and Pensions

Perhaps not politically correct, but it is a more accurate description of "life" insurance.

You should be receiving in the mail, if you haven't already, your new life insurance policy negotiated by this office over the last few months.

Though Local 44 provides this benefit to its members and we have been able to increase the coverage each of the last two years, it is really only an assist to our members in time of need. I encourage each of you to examine your own personal coverage beyond the resources the Local offers.

It is important to realize the "necessity" of life insurance to any future financial planning. It is designed to take care of the obligations we leave behind. It should <u>not</u> be a windfall to make your heirs rich!

Following are a few basic guidelines when shopping for your own personal insurance.

- 1. Buy only TERM insurance! For 95% of us term insurance is the only way to go. Whole, universal, or variable insurance policies entice you with an "investment" you can borrow from if necessary. Life insurance policies are horrible investment vehicles with numerous hidden costs. When you borrow on your insurance, you are borrowing your own money! Then you get to pay back your money with interest to the insurer!
- 2. Not everyone needs insurance! Children and single persons without major debt don't need to be insured. Often families add riders for their minor children. Or, adult children get a policy with their parents as beneficiaries, ostensibly to pay for funeral costs. A better route is to open a CD with a few hundred dollars, and add in the money monthly you would have paid to your insurance. If the worst case scenario doesn't happen, at the end of several years you have a personal savings

account you can access. If it does happen and your beneficiaries are on the investment vehicle you chose, then chances are the investment amount covers your expenses.

- 3. How much insurance should you carry? There are two good methods of determining your policy amount. The first, cover your major obligations; your outstanding mortgage, children's college expenses (if they are young children, their anticipated expenses), and a couple of years salary for your spouse. The second, 5 to 8 ½ times your yearly income; on \$50,000 a year, you should have a \$425,000 policy.
- 4. You have minor children as beneficiaries. If minor children are your beneficiaries, open a trust and make it the beneficiary. Without a trust, the courts will hold your policy payoff until your minor children reach 18 and then they will give them the lump sum. With a trust, the money will be available almost immediately, and you may designate when, how much, and at what age your children receive their money.
- 5. When do you increase or decrease your policy? Increase if you have a new, higher mortgage, a new baby, an increase in yearly income, or if you have a non-working partner and small children. The latter in order to pay for extended childcare should a surviving spouse need to go back into the workforce. Decrease if your mortgage has significantly reduced or if your children graduate college.
- 6. Shop every few years for better deals. Don't wait until your term expires. Insurers often offer reduced rates or even increased coverage for the same or less monthly rate you are already paying with shorter terms. If you have a 20-year term, shop for a 10 or 15 year term after a few years, where insurers offer better rates.
- 7. What about ROP? Return of Premium is a new type of term insurance. At the end of your term period, if you are still alive, you receive everything you paid into the policy, every cent. The catch? The monthly payments are generally 1½ to 2 times the monthly payment of standard term policies. However, if you paid \$500 to \$1,000 a year for the coverage, you would have \$5,000 to \$15,000 coming back to you at the end of the policy. Something to consider especially if you are younger and the odds of your living many decades more is likely.

Understanding Your Pension(s)

We often don't understand how our pensions work, much less how to save for the future on our own.

You hear the lament that our pensions are so flush that we ought to lower the retirement age. Nice idea on paper, until you realize what you're asking for. You hear the figures of one or two billion dollars in the pensions and it seems obvious and easy. Why not let us retire five years earlier?

Lots of reasons: First, it is not just the 6,000 members of Local 44 who have access to those funds; the collective pool is 40,000 to 50,000 individuals or more. With those numbers, your individual cut of a billion dollars is \$20,000-\$25,000 in a lump sum payment, and then the billion is gone. Or, you could have \$400 a month for five years, and again, the billion is gone.

Obviously, not all our current members are accessing the pension right now, but it indicates how quickly those big-sounding numbers can evaporate. Our Plans are projected into the future 20 or 30 years.

The average age of those using the fund was 42 years old in 2002; in 2007 it's expected to be 43.6 years old. That's an increase in the population average of 1.5 years in a 5 year span. The Baby Boomers are hitting retirement age. People who want to claim it is an easy thing to lower the retirement age don't understand how pensions, insurance or medical coverage work; they don't understand actuaries, estimates, demographics, and projections. It sounds reasonable until you actually understand it and break down the numbers.


Oh, and two more points on "our" Plans. They're negotiated. That means it's contractual, and it's something your BA and President Short would need to bring to the bargaining table, the next time in 2009. That means they sit across the table from the Producers and have your Pension age as a bargaining chip. What do you give up to get the lowered retirement age?

Second, visit the land of dreams and assume IA President Short and the AMPTP President Nick Counter do a big kumbaya and agree to lower full retirement to 50 years old in the next contract. That contract now goes before the Joint Board of the Motion Picture Plan. That

Tell them to protect our interests by keeping other countries from using illegal subsidies and to encourage incentives here in Los Angeles to help keep overhead down. And, when working on the streets be good neighbors so that those citizens of Los Angeles who are not in our business will not speak out against our interests.

By having enough work for everyone to keep their medical and pension hours up you, and all our co-workers, can sit back later in life and reminisce about the good ole days just as I am doing now. This industry can be very good to you, but it can also be harsh if you lose one or two contacts who go to work in Canada, New Mexico or at the new Raleigh Studios in Eastern Europe.


Retiree Spotlight: John Angelo

At the young age of 84, retired Prop Man John Angelo hasn't let the term retirement slow him down for a second. In fact, his daily routine is enough to make anyone sweat just thinking about it. As an entertainment guru, Mr. Angelo has spent a lifetime sharing his talents with the industry in front and behind the camera.

The life of John Angelo began on June 24, 1922 in Newark, New Jersey, which is surprising enough St. John's Day. He was brought into the world by Sam and

Josephine Angelo, however, shortly after the birth of his two younger brothers Sam and Joe, his father passed on. At thirteen, Angelo discovered he had the natural ability to dance, and pursued his calling. As a young man he relocated to New York where he preformed as part of the Ballet Company and worked the Broadway stage. Angelo's astounding talents landed him the opportunity to perform Musicals at the MGM as well as dance for some of the most famous Las Vegas Hotels. John's

Angelo learned the tricks of the trade at Columbia Television where he worked on the series hits, "Fantasy Island," "Perfect Strangers," "Knots Landing," "Falcons Crest," and "Ziegfeld Follies."

One of Angelo's comical moments in the industry came about while working on the Robert Wagner series "Hart to Hart." While propping the set, Angelo's French

style telephone mysteriously disappeared. When it wasn't returned in a timely manner, Angelo threatened to practice voodoo on the individual who stole the phone. Needless to say, the phone reappeared within a matter of minutes. Angelo recollects that another unforgettable moment in the industry was when he was told to "return the props to the "Gold Room." Angelo was unaware of its location, and began hunting for it everywhere, unsuccessfully. When Angelo finally asked where it was located, a gentleman on set directed him

to a fenced wire chicken coop and replied, "That's the "Gold Room." Angelo still laughs about it.

As time went on, Angelo had the honor of working at Lorimar as an assistant to Pierre Beavadis, as well as lending his talents to Warner Brothers, MGM, and Sony prop departments. Angelo went on to explain that he loved working in the business, and expressed, "I enjoyed being close to the stars and getting to know them. I met so many

wonderful people, and happened to learn the business fast."

At age 70, Angelo came to the conclusion that it was time to call it quits. Since his retirement from Local 44, Angelo has continued to teach acting through West Hollywood Theater Workshops. His video taped version of his classes, has earned him the West Hollywood Public Access User's Choice Award. Brother Angelo's love for people, his passion to give back to the community, and long-standing engagement in public affairs, has gained him the honor of becoming recognized as "Outstanding Senior" in the city of West Hollywood.

Retirement has also given John the time to produce and direct his own award winning, West Hollywood talk show, the "John Angelo Interviews." On top of it all, Mr. Angelo gives aids assistance at a local Japanese healing center, and reserves time to devote to his Baha'i faith. Despite the fact that Mr. Angelo continues to juggle a loaded schedule, he never forgets what is important to him; his long-time pal Eddie Langdon, collecting new friends, maintaining old relationships, and dedicating his time to Local 44.

is 36 members (half from labor; half from management) sworn to the fiscal solvency of the Plans. The Plans are a Taft-Hartley Plan regulated by the federal government. They can go to jail if they don't protect the funds for future use. They take one look at the numbers and tell Presidents Short and Counter to take a long walk off a short plank, and nullify that contract proposal as irresponsible.

Not to say it's impossible to make progress in that direction; just remember you're moving a mountain, not kicking over a rock.

On a more immediate front, do what you can with what you've got already. You've got two pensions; 3 if you're saving on your own.

<u>Your defined benefit amount</u>: That's the monthly payment you're going to get when you do retire. It is based on your age, your years qualified, and the number of hours you have logged in your career. You will get this monthly the rest of your life.

Your Individual Account Plan: The IAP is unique to the Motion Picture Industry and truly one of our greatest perks. Over a year ago, I tried to research private sector plans that had two separate employer contribution plans; I couldn't find any.

Your IAP belongs just to you. It is a percentage of the gross wages you earn in your career. It was started just ten years ago. Right now it's 5% over and above your wages; in August 2007 it goes to 5.5% and in August 2008 to 6%. This is a lump sum pay-out at your retirement. Many 44 members may expect at the end of their careers to have a six-figure pay-out.

Track your hours each year! DON'T EVER THROW AWAY A PAY CHECK! EVER! Why? Each year you're going to get a statement from MPIPHP. The most important thing you can do is check your yearly numbers. It shows all your contributions and hours. Match them with your checks; if your hours or your wages are wrong, fix it now, not ten years from now. And don't let ten or twenty hours you got shorted slide. It might not seem like much now, but 10 hours each year for 30 years is 300 hours, that's another year or year and a half you would need to work at the end of your career to make that up. If you're just short of qualifying for the

next level of benefits, that's a big deal.

Why keep all your checks? Assume you kept track of your hours each year and fix mistakes as you found them, but when you retired in 2020, the Plans lost your contributions in the new database they switched to in 2017, and they don't have any contribution from you for the year 2008. You go to the dusty box in your garage, pull out your banded checks from 2008, and can physically prove to them you worked 500 hours that year.

Living a 40 hour lifestyle: Many of you won't heed or consider this option for a third retirement fund, you should. This is the best financial discipline you can learn and gives you teh most control of your money! Learn what a 40 hour paycheck is. Put away any overtime in an investment vehicle. If you have a good 6 month run with overtime savings, and you hit that 2 month drought, you'll have the reserves. If you have a good career and you've stashed your overtime into an investment account and lived a 40-hour lifestyle, you now have your third retirement account, and it's all yours to control.

Moving On

For those of you who voted for me, and more importantly, for those who supported me, from the Executive Board, from Coordinators to Special Effects, from Set Decorators to Prop Masters who stepped up to offer their time, I thank you. To the rest of you (many that I'd never met) who offered encouragement, thanks all the more. Finally, we can move on.

The election of 2004 was the election that wouldn't end; taking an extra round of run-offs and lasting 9 months from petition pulling to inauguration.

This election will go down as one of the most underhanded and vile elections in a Local noted for colorful and often lowball methods of campaigning.

I've said it before and it's worth repeating. This is not the Local of the past. It is new; it is different; it is changing. You may have felt disconnected before, we don't want that anymore. Get connected, you'll see the difference.

EXECUTIVE BOARD MEETINGS HIGHLIGHTS

Many of our members have expressed an interest in the content of the monthly Executive Board meetings. Below is a summary of the most recent meetings. These are only brief highlights and do not contain great detail. They are meant to give an overview of things that were discussed, not a fully accurate account. Any member wishing to read the minutes of the Executive Board in their entirety, may do so by appointment though the Secretary-Treasurer's office.

Wed., April 4, 2007 Special Meeting - SCEE

The Board went into Executive Session for 51 minutes

Wed., April 4, 2007 Regular Meeting

Report: Election Committee

The Committee handed the Board the official results of the just concluded round of elections. All offices except for two were decided. The 2 remaining positions would need a run-off round of elections: Sergeant-At-Arms, and the 3rd Propmaker Representative position.

The Committee reported on the steps that they have taken to develop procedures to separate candidates from the election process, and have a manual in place for future Election Committees.

This election process seemed to run fairly smoothly considering that it was the first run under the new rules.

Report: Business Agent

The General Membership meeting had a low turnout, but the members who were there expressed that it was one of the more informative meetings they attended.

A report on ongoing grievances was given.

One grievance settlement was given to the MPTF and a thank-you letter from the Fund was read for the charitable contribution from Local 44

A no hire letter against a member was removed from Fox Studios.

BA Brown testified before the California State Assembly in Sacramento on behalf of Local 44 regarding incentives for filming in California. The BA read his letter of testimony into the record.

A request was made to make Anthony Pawluc the third Assistant Business Agent. The budget for 2007 already included an approved 3rd Asst. B.A.

The Board went into Executive Session for 10 minutes.

Motion: For Board consent for the hiring of Anthony Pawluc as an Assistant Business Agent.

Motion passed with one abstention.

A letter of apology to the members of Local 44 was read regarding the misidentification of Set Decorator Gretchen Rau during the memorial portion of the last Academy Awards. The letter would be published in the Newsreel.

Report: Secretary-Treasurer

The S/T provided a handout on new initiates and their relation to the budget.

A brief report was given on the General Membership meeting that just concluded.

The third installment payment for the 301a filing for the elimination of foreign subsidies was sent.

Rhonda Bragdon, long-time 44 staffer retired. Her duties of collections, disability and death benefits were temporarily being divided between existing staff.

Discussion: A revisit of a previous grant request was reviewed.

The Board went into Executive Session for 16 minutes.

The E-Board directed the Secretary-Treasurer to send a letter to the member regarding the monetary grant request.

Discussion: A review of the Local 44 membership kit was done. It was noted that the kit was given to new members and was years old and outdated. The S/T noted that portions of the kit are still handed out to new members at orientation. Was it time for a revamp? It was suggested that the main focus of the Board should be the completion of the Constitution rewrite.

Discussion: The President proposed having an E-Board handbook with instructions and reminders to new Board members upon their inauguration.

Discussion: There was a desire to expand the number of facilities that Local 44 would accept for welding certification.

Motion: To expand welding certification program to other accredited facilities.

Motion passed.

Discussion: If it was possible to have photo ID membership cards. It was pointed out that the cards are issued and designed by the IA not Local 44. Also, it would require taking photos of 6000 members annually and some members might believe the photo cards were now passes onto studio lots.

Discussion: General Membership Meeting Questions.

Drug testing: A member had suggested drug testing. Only the Teamsters were required by law to submit to drug testing and that was a safety issue. If the member was speaking of officers of the Local, it might be possible to institute a test if an official were suspected of intoxication, but it might be illegal and would have to be referred to counsel.

Auditing campaign material and opt-out on mailings: It was pointed out that the DOL would not allow censuring of campaign mailings. A libeled member did have the civil courts to take care of personal attacks.

A Retiree Representative on the Board: This was a continuing request. It has always been pointed out that this position cannot legally be created.

Wed., April 18, 2007 Regular Meeting

Report: SCEE

The Committee meeting on the situation with past members of the SCEE gave their findings and suggestions. The SCEE is a standing committee that's been around 15 years. The Board wished to acknowledge their efforts and the committee brought its proposals.

The Board went into Executive Session for 16 minutes.

Motion: To accept the SCEE report.

Motion passed.

Report: Downey Studios

The Board went into Executive Session for 50 minutes.

Report: Constitution

The Articles 1-8 had only one small area returned to the Local for clarification by International President Short. It would be fixed and resubmitted.

Report: Business Agent

An update on the IATSE/AMPTP cooperative meeting in Palms Springs was given. The BA, S/T, and VP of Local 44 attended.

A request for the Plans to break down contributions to the health and pension plans by type of production was discussed.

The backlot Locals combined to address the weekly on-call rates studios were using improperly.

Asst. BA Ahrens attended the California legislative conference on behalf of labor organizations lobbying the government on health care issues. Additionally, there was caucusing and lobbying on behalf of AB1696; tax incentives to keep film production in California.

The upcoming craft meeting schedules were announced.

Research into a universal sexual harassment course similar to the Safety Passport program was discussed to eliminate the need to participate every time a member switched employers

The upcoming dates for the Rebuilding Together projects were announced. Local 44 members were playing a large role in these assistance programs.

Report: Secretary-Treasurer

The S/T handed out the monthly investment performance chart that indicated the Local's money had continued to grow despite a poor performance in the prior month and minimal contributions from the Local.

4 members not covered by our life insurance policy due to problems in past administrations had died. A request was made to pay benefits from the new life insurance account created just for this purpose.

Motion: To pay benefits out of the Local 44 life insurance fund to 4 members.

Motion passed.

A bowling league was being started for the members.

A new revamp, course A at Safety Passport was being created and all members of the Local would have to comply with it.

There has only been 30% compliance among Prop Masters with the Weapons Safety course.

Property members will soon be slated to take the Weapons Handling course.

Discussion: Having a screening night as in the past for movies at the Television Academy. It was noted that vandalism of the property had ended our previous use of the facility.

Discussion: A member at the General Membership meeting asked the feasibility of Shop Stewards calling lists of members to encourage attendance at membership meetings.

Understanding Retired Categories

In 2005, several new categories of retired membership were defined, ostensibly to make retirement options more diverse, but sometimes it still gets confusing. There are five types of retired categories:

<u>IA Retired</u>: This is a fully retired and no longer paying dues position. You must be 65 years old and fill out a form with the Local to send to the International. You lose none of the benefits of Local 44, but you do lose your voting privileges.

<u>Voting Retiree:</u> This is a fully retired position, but you pay the International per capita tax in order to vote. You must also be at least 65 years old and have at least 20 years in the IA. This group also has all the benefits of Local 44, but can keeps their voting privileges.

<u>Pensioner:</u> This is a *non-working* category. This is for members who retire before they are 65 years old, but have at least 20 years experience in the IA, and is collecting a pension from the Plans. This group cannot work without endangering their pension, but isn't old enough to qualify for the above categories. All benefits and voting privileges are available.

Reduced Active: This is a *part-time work-ing* category. You must be 65 years old with 20 years experience in the IA. You want to work a maximum of 39½ hours in a month. This will not effect your pension. You have all benefits and voting privileges.

Disability Retired: If you have a Social Security Disability Award from the federal government and you are no longer able to work, you may retire out at any age as an IA retired member. You do lose your voting privileges just as with a regular IA retired, but are able to access the Local 44 benefits.

If you don't fall into any of the above categories you must remain Active or Inactive or go Honorable Withdraw until you do. Honorable Withdraw pays nothing until they reactivate, but loses all benefits and privileges. If you are Inactive, Pensioner, Voting Retired, or Reduced Active and take on regular work you must pay Active dues for the quarter in which you work.


