## **Business Agent's Report**

I want to thank the membership for your overwhelming showing of support in our recent elections. I am humbled by the honor to serve you, and the level in which that support was shown. I have dedicated myself to bringing you the highest level of representation and honesty that can be provided. As we face new and more difficult challenges with a rapidly changing industry and an uncertain economic future, I will remain true to that dedication. Again I want to thank you for placing your faith in me, my administration, and your Executive Board.

#### <u>California Film and Television Tax</u> <u>Credit Program Is a Job Creator!</u>

Day after day and set visit after set visit, I am asked about the outlook of production here in Los Angeles. After the last few years of work slow downs, strikes, fires, runaway production...it's time to look at where Hollywood was and where we are now.

Approximately 15 years ago, Producers began shopping their products to the lowest bidders, starting with Canada, New Zealand, Australia and moving on to the United States, Louisiana, New Mexico, Arizona, the list goes on....Groups were formed to fight this "Runaway Production" movement.

Lobbying efforts by some of these groups sought funding to fight this fight, from industry Unions and Guilds, only to end up with nothing to show for it but invoices from Washington attorneys. Member task forces grouped to demonstrate in Sacramento with picket signs and truck rallies.

Meeting after meeting with political allies were taken by every entertainment labor organization who dared to jump into the arena of political turmoil in Sacramento. A few of those Sacramento allies drafted California Tax Credit legislation with hopes of unilateral support across the Golden State, again only to fail when running up against opposition from Legislators outside of Southern California who failed to see the benefits of such legislation for their own Northern California constitutes. Calls to our industry rich Governor fell on deaf ears.

Attempt after attempt to institute some remedy, some leveling of the playing field, to reverse the losses of this trend, the loss of these jobs, continued to have the same result, nothing. With the failure of Assembly Bill 777, most supporters threw up their hands in defeat.

As your Business Agent, my administration, your Union, Local 44, refused to give up the fight. When others stopped going North to Sacramento, this administration made more trips, more testimonies and more phone calls. Along with a small dedicated unit of the IA and Hollywood Labor we remained hopeful and diligent.

Then in February of 2009, as if suddenly Sacramento awoke from its collective slumber, passage of the first ever California Film and Television Tax Credit Program became a reality.

The tireless work and persistence of the collective voice was finally heard. The dedication to reach success by the California Film Commission and its director, Amy Lemisch, no longer a pipe dream but a workable tangible project, held tightly in her hand.

About two months ago my office sent out to you a list of productions that if not for this California program most likely would have been produced outside of California, and taken every single one of its jobs along with it.

Since then that list has grown. And preparation for the next round of project applications will shortly be underway.

Is there a great deal of tax incentive productions still taking place outside of the state? Yes there is.

But there have been tax incentive productions that have been produced here in California. There are tax incentive productions currently being produced here in California. And there will be further tax incentive productions produced here in California.

- The estimated total spent by these Productions in California stands at over \$1 BILLION.
- Estimated below the line wages paid out through this project: \$400 MIL-LION so far.
- An additional 673 shooting days in 2009 added, strictly from incentive program productions.
- FilmLA reported a 2009 4th quarter increase in feature film days of 12.9%. This increase was due exclusively to incentive program projects.

For the first year of the Tax Credit program, as of Friday, April 2nd, this program has created jobs and put to work: 1152 members of Local 44.

This is where we were, and where we are now. In terms of where are we going?

The California Film Commission is slated to start accepting applications from productions June 1st, 2010, which will be on a first come first serve basis. We can only remain optimistic that these productions will provide as many if not more jobs for our members.

## Alert to all members working out of State!

Increasingly, members are working out of state. It is important to know that State Disability Insurance (SDI) is not deducted from your earnings. SDI contributions are not made by the producer. Some States deduct for disability insurance and some do not. You can research on-line to determine in advance if the state you are going to will make a deduction from your earnings. If you have already worked out-of-state, you should see the deduction on your pay stub if one exists. If you become disabled, it is possible for your doctor to report your disability to that state in an attempt to open a claim on your behalf. If you know you will be working out of state, you can purchase supplemental disability insurance from a company such as AFLAC just to make sure you have some coverage.

When applying for unemployment benefits it is also possible that those deductions/contributions will need to be applied to supplement your California unemployment insurance. There is a form for Motion Picture Industry Pension and Health plan contributions that must be filled out and given to the production company in order for those contributions to be made into the plans. The form is called the 'MPI Plans as Home Plans' and can be found on our website, www.local44.org, under the member's link. ## "True Blood" - Life Begins at Night

The Golden Globe winning series "True Blood" has been entertaining vampire enthusiasts since 2008. With its 3rd successful season well underway, Local 44 Craftpersons continue to raise the bar to meet the demands of the writers' creative approach to think outside of the proverbial box.

Upon visiting stage six at Renmar Studios, the "True Blood" construction crew headed by Coordinator Mike Wells and Foreman Bob Thompson was in the process of perfecting the interior of the Mississippi Mansion. Wells describes, "We built an opulent, traditionally southern, old money mansion with a magnificent elliptical stairway, inlay marble floor, hand painted wall coverings, and sixty different mouldings in only six weeks." Foreman Bob Thompson expands, "Inside the mansion we built a study room with a fireplace, wall, and bookcase that wild, and a dining room with an elaborate wallpaper mural." Wells calls the finished product "breathtaking" due to the high level of talent of his crew.

While the True Blood construction team was busy building their Mississippi Mansion masterpiece, Set Decorator Laura Richarz and her crew were at "The Lot" bringing to life "Fangtasia," a wickedly innovative bar that attracts humans who want to explore vampire life. Richarz explains, "Our stage version of "Fangtasia" has been really fun. Rusty Lipscomb dressed the original location in Long Beach for season one and most of the dressing was rented or already at the location. To reproduce it, we had to search high and low for a variety of fun things."

Property Person Michelle Souza was tasked with finding religious, satanic, 'Day of the Dead' items to dress the set with, which was not only challenging but required a great deal of research. Inside the bar one will find what Set Dresser Charles Randolph refers to as "a fantastic mixture of voodoo meets American Catholic." Hung on the walls of the bar are velvet paintings, pleather East Indian masks, skulls, and a portrait of George Bush with fangs biting the neck of the Statue of Liberty. Amongst the primarily red and black decor is a full bar, tables and chairs, and a vampire para-

phernalia gift stand. The crew's excitement over the finished set was both moving and contagious.

As the Newsreel team viewed several other finished sets, it was obvious that the same level of craftsmanship went into each of them. The brilliant work of all the crews was observed in the interior set of Sookie's house, the dark

and decrepit torture chamber, and inside both Sam's office and bar. One particular set that exuded Decorator talent was Sam Merlot's bar. Through extensive research, Richarz and her crew saw to it that every object placed into the set was well thought out and a direct representation of Louisiana. Property person Paige Bossier was an excellent addition to the crew since she was born and raised in Louisiana. All

of the products, animals on the walls, newspapers, refrigerator items, and business cards in the establishment were from Louisiana. Richarz tells, "The work we put into "True Blood" is very intense, and very creative. The demand on the crew is enormous, but they have really stepped up to the plate."

#### "Thank You"

As you know, we have completed our triennial officer elections. I am humbled that you overwhelmingly selected me to continue serving our membership as your Secretary-Treasurer. First, let me thank my family for always being there and supporting me in my personal and professional endeavors. I thank my staff for their increased level of professionalism and dedication to our membership day in and day out. I thank all of my Union brothers and sisters who assisted me during the election process in the field and on the phones, and have remained loyal during my years of service to our membership. Last but not least, all of you who participated in the election process by voting, allowing me the honor to continue to work for all of our members in the accountable, professional, and pro-active manner our Union deserves. I look forward to Local 44's continued progress and stability as we journey together into the future.

Additionally, I congratulate and thank Business Agent Ed Brown, President Erin Hennessey and our entire Executive Board, Trustees and Delegates for their devotion and service in the past, and now, the next three years.

Our Annual General Membership meeting was held at the Glendale Hilton on Saturday March 27, 2010 with an increase in attendance and membership participation for the third straight year. I thank all of you for being there. I hope we all keep our commitment to each other by bringing or calling two or three more members to next year's meeting.

#### - CALLBOARD -

As we move into spring time, we typically think about "spring cleaning" at home or in the garage. Here at Local 44, we are cleaning up members' certifications (e.g. Powder Cards, Firearms Licenses, Welding, Scuba Diving or ServSafe certifications, Locksmith, etc.) in the Callboard and making sure those on file are current and not expired. If you have recently qualified or renewed any of your certs, please be sure to get a copy of them down to the hall so we can keep your records accurate. If you have questions, please call the Callboard.

#### - BUSINESS OFFICE -

Many members have inquired about our Union's Membership numbers. Some rumors or exaggerations have put our membership totals down anywhere from 400 to 800 members in the past two years (2008 and 2009). This is simply NOT true.

However, because of the curiosity, my office did a study which revealed the following;

We compared members in 2008 who became dropped, requested a leave of absence, passed away, transferred to another union, or retired compared to members who reinstated themselves, (from dropped status, leave of absence, etc.) or joined the union, and found there was a 101 decrease in membership. In 2009, using the same process mentioned above, we saw a decline of 126 members. Clearly these numbers prove that even though we have had a rough past couple of years, our membership has remained intact.

I am proud to announce that after a trying and difficult negotiation process, we have a new three year deal for our membership's \$7,000 Group Term Life Insurance Plan. When I began negotiations, our carrier was not interested in more than a one year deal with a 40% increase to our annual premium. This was obviously unacceptable. When we returned to the table, their best offer was a two year contract with a 19.1% increase. With that, I took our business to the open market. After requesting quotes from twelve other carriers based on our current plan design, MetLife was willing to accommodate our plan's structure and budget. When we offered our (then) carrier another shot at Local 44's business, they were unable to match our tentative deal, offering only a three year agreement with a first year rate pass and a 16.4% increase in the remaining two years. When the dust settled, we signed a three year rate guarantee at only a 1% increase per year covering over 5,900 lives. Each of you will receive the MetLife literature in the mail from Local 44 in the next few weeks.

Keep up with the rest of your spring cleaning, if you are unsure who your current benefactor(s) is, or have not updated your beneficiary information for some time, please contact the Business Office.

#### - WEBSITE -

If you are not registered with www.local44.org yet, and are interested in getting information from Local 44 quicker, please visit our site to register so you too can join the growing ranks of members who receive information faster electronically.

As some of you may know, for years our

union's computer programs didn't share information between our internal departments (e.g. Business Office, Callboard, Business Agents, etc.).

As I have reported, part of our website phase two improvements is linking all three of our systems (Trump program financial/dues) Callboard (contact information/out of work system), and www.local44.org). Now more than ever it is important to report your work history since the dues program will automatically tally day fines if you are delinquent with your dues payment and working or listed as working in the Callboard. You can avoid this confusion and day fines all together by keeping your work status up to date with the Callboard and paying your dues on time.

#### - NEWSREEL -

As always, our Newsreel team stands ready to go to your location, photograph and interview crews, and feature your production or shop in our Union's magazine. You can call us at the hall or send an invitation to newsreel@local44.org In a little over a year, we have had six editions of Newsreel (including this issue) that have featured 15 Features, Television Productions or Union Shops. It is a lot of work but it's fun to see members go into detail explaining the work on their sets and of course, smiling for the camera.

The Local is still actively pursuing and collecting current Hollywood, CA produced movie and television posters to display down at the hall. We are asking any crew members who worked on these productions to autograph the poster before we frame and display it. If you have posters, or know of any source we can contact, please forward that information to our Call Board Stewards (818-769-2500).

As this issue goes to press, we will have had the return of Movie Night (April 13, 2010 featuring "Date Night") and our second Parking Lot BBQ (April 16). I hope I bumped into you at both of those events. If not, I look forward to seeing you at Local 44 Magic Mountain Night on Friday May 14, 2010. Discount tickets are on sale in the business office.

Once again, thank you for all the support and trust you have instilled in me to continue working for our membership. I will remain steadfast in my duties and continue to deliver accountability, fairness and loyalty to our membership as your Secretary-Treasurer.

## New safety pass course requirement

Contract Services Administration Training Trust Fund (CSATTF) has deployed the Safety Pass training program, "A2"-Environmental Safety course! This course covers updates in safety standards due to changing regulations and addresses important safety topics such as studio lot and location safety, heat illness, severe weather, disaster and emergency response, environmental awareness, transportation of dangerous goods, electrical safety, and workplace cleanliness. Based on its comprehensive content, the "A2" -Environmental Safety course has been added as a required Safety Pass course for all individuals for which CSATTF does Safety Pass training (approximately 43,000 individuals).

The timelines for this course will span a

two-year period. The timeline deployment will be segmented by Local/Guild. Notice of this new requirement and its associated timeline will be sent to individuals approximately 60 days before the inception of their timeline. Local 44's timeline will be confirmed about a month before the anticipated 60-day notice goes out to the membership. For (continued on page 15)


## Spotlight on Russ Goble

Fifty years ago Property Master Russ Goble began his lifelong career and dedication to Local 44. It all began at Ziv Studios in 1958 when Goble traded in his relaxing afternoons of bodysurfing for a taste of show business. His first day on the job was spent working under family friend Special Effectsman Bob Overbeck where he transformed industrial coal into household coal by breaking it up into smaller pieces. After proving himself worthy enough to embark upon a career in the studios, Eddie Hill was given a letter recommending Goble for membership into Local 44. Proudly, at the ripe age of 20, Goble received his first Property gig at Columbia Studios.

Goble tells, "At that time the average age of a worker in the studios was 68 years old, so it was difficult being such a young guy just getting started. I had no idea what I was getting myself into. I was told I'd need a hammer, screwdriver, and a pair of pliers; so that night I went out and bought my first set. I had no clue what I was supposed to do but I was determined to learn."

At \$2.92 an hour, Goble got in his first 28 days at Columbia Studios and his remaining 2 days at Warner Bros. On November 17, 1959, Goble pledged an oath



of Brotherhood to Local 44. For the next five years Goble worked on various swing gangs and strike crews in hopes of landing a permanent company job. His first assignment as a Leadman was on the feature "Captain Newman, MD." This became a fond experience for Goble because he was transported to Fort Wanda, AZ by limousine to perform his duties. Finally, one day Goble received the phone call he had been waiting for. He was asked to work with a Master at CBS on the production "Baileys of Balboa." Although it didn't turn out to be an assistant position, he was able to absorb the experience and apply what he had learned toward his first Assistant Master project which was a spin-off of the original "Gunsmoke". By age 26, Goble had fully transitioned into the craft of Property Master and lent his talents to television productions "Goodnight, My Love," "Sybil," "In the Heat of the Night," "Dante's Peak," and such films as "Barbarossa", "ET," "Murphy's Romance," and "Stand By Me."

One memorable project of Goble's dates back to his time on "Earth II," a show geared towards generating funds for NASA. Goble reveals, "For this project I had to acquire (continued on page 15)

Over the course of the last three seasons, Wells and his crew have been responsible for nearly twenty-three permanent sets that continue to expand from season to season, plus numerous swing sets that they build and strike each episode. Wells describes one particular project that relied heavily on his Coordinating skills. "The exterior of Sookie's house is a set we built from the foundation up on a ranch in Malibu. I had all of my great Propmakers, Painters, and Greensmen working hard to make it convincingly appear to be an actual person's residence. First we had to determine the correct position of the house in terms of the land and

sunlight, and then we leveled the ground, installed the irrigation system, and began to build an actual house, not just a four-wall set. The finishing paint and plaster details, and the sod and trees we planted, made it look like an old disjointed farmhouse that had been tacked together over the course of several generations."

The Local 44 Greensmen working on this series mastered their approach in turning Malibu, California into Louisiana terrain. Greensman

Chris Dery describes their work on the Sookie house exterior, "True Blood is one of the most greens heavy shows in Hollywood. For the exterior of the house we planted over 300 plants from a 5 gallon pot to a 36 inch box and laid out 17,000 sq feet of hydro-seed. It was a proud moment when the deer of Malibu began to graze on our grass."

Each of the respective crafts has offered the highest level of skill and talent to the series "True Blood." This is reflected in both ratings and awards. Perhaps the greatest compliment came when one of the writers of the series asked, "How did you find such a special little graveyard (pictured on page 4) out in the middle of nowhere?" Wells reveals, "What he didn't know...is that the crew had just built the cemetery in Malibu on the same piece of land we'd been using the entire time."

## Brown v. Ceglia Finalized

On September 15, 2009, a trial was held, before the Local 44 Trial Board, on a Charge brought by Local 44 Business Agent Brown against Member Tom Ceglia. In his Charge, Business Agent Brown alleged that T. Ceglia violated several provisions of Local 44's Constitution and By-Laws while performing services on the struck non-union Levinson production, "Mega Storm".

At the September 15 trial, Brother Ceglia appeared and entered a "not guilty" plea with the Trial Board. After due consideration of the evidence and witnesses offered by Brother Brown and Brother Ceglia, at the hearing, The Trial Board sustained:

• Charge 1 (Disloyalty)

- Charge 3 (working with Non-Rostered Persons)
- Charge 4 (Disregarding Orders)
- Charge 5 (Obeying Strike Call)

On Charge 2 (Unfair), the Trial Committee found that the evidence was not sufficient.

The Trial Board also assessed the following sentence against Brother Tom Ceglia;

- Charge 1: a fine of \$1,962.00 equaling a forty hour work week at "Licensed Powder Man" rate.
- Charge 3: a fine of \$200.00.
- Charge 4: a fine of \$350.00.
- Charge 5: a fine of \$200.00.

At an Executive Board meeting held on October 14, 2009, Tom Ceglia appealed the Trial Board's Decision. The Executive Board found that since the Trial Board found Ceglia guilty of charges 1, 3, 4, and 5, on the grounds that Ceglia provided his services on or about March 23 through May 6, 2009 to the struck non-union production "Mega Storm," the Executive Board amended the trial boards ruling for charge 2. (Unfair) and found the accused guilty and imposed the maximum penalty of \$1,000.00, as allowed for by Article 7, Section 14, of the Local 44 Constitution and Bylaws. In addition, the Executive Board ruled the penalties for the charges of guilty be levied at the amounts recommended by Local 44's Constitution and By-Laws:

- Charge 1: a fine of \$1,962.00 equaling a forty hour work week at "Licensed Powder Man" rate.
- Charge 2: a fine of \$1,000.00.
- Charge 3: a fine of \$1,000.00.
- Charge 4: a fine of \$500.00.
- Charge 5: a fine of \$500.00.

The Trial Board's and Executive Board's decision, subject to Brother T. Ceglia's right of appeal to the International President was exercised by Ceglia on November 24, 2009. After reviewing all documents, evidence, testimony, and trial transcript, International President Loeb sustained the charges and fines in their entirety on February 25, 2010. After President Loeb's ruling, Ceglia paid the fines in full and the matter is now concluded.



## **Ciao Jimmy**

Vincenzo Buffolino's life-path and mine first intersected in a brief, chance encounter on a Sunday evening in Manhattan, back in the 60's. The boys and I were hanging out on 'our' stoop on Second Avenue, downing our last beers of the weekend before we all headed home our separate ways. As we sat there solving the problems of the world, some guys approached, trying to get past us to go up the steps. "Slide over, this is union business." I heard a gruff, no-nonsense voice with a distinct Brooklyn-Italian accent say. We shrugged and moved aside--it was nothing to get worked up about. At that time, I didn't give the incident much thought--little did I know that in years to come, just how familiar that Brooklyn-Italian voice would become to me!

Life went on and in the 1970's I moved out to California. I was fortunate enough to get into Local 44 and the movie industry. Then, in 1980, my life-path crossed that of the man from the stoop again. He looked familiar--then I remembered him--by his unique, one in a thousand voice! But even more surprising was that he remembered me from that brief meeting as well! "Watch me and learn, kid." was his advice to me. He had a confident, self-assured manner. Not arrogant or condescending or acting as if he was doing me a favor--Vincenzo Buffolino, or 'Jimmy', as we came to know him, came across as a professional, as someone who knew what he was doing. His attitude inspired my own confidence in him and I instinctively trusted him. It proved to be one of the most enduring and rewarding acquaintances in my life. We formed a close working relationship that over the years would grow into personal friendship as well. Jimmy was truly one of the smartest and greatest men I've ever met in this business. I believe the greatest gift Jimmy left me was not how to be a good leadman in our department but how to be a good leadman in life and for that I am eternally grateful.

Yes, Jimmy was a colorful character indeed--'that crazy Italian guy from

Brooklyn'! His early history was as exciting as one would expect for someone like him. Vincenzo Buffolino was born in Brooklyn on December 12, 1928. After an all-out, full volume, wildly prototypical Italian argument with his father. Jimmy stormed out of the house. And promptly joined the Army Air Force. Although he was only sixteen, he looked older and so he exaggerated his age by a couple of years. He was assigned as a tail gunner in a bomber. Two years later, when the WWII was over, he returned home. But as it turned out, the war at home apparently was not--the argument with his father picked up right where it had left off. Jimmy turned around and left home once more, this time signing back up for another three year hitch with the Army. He ended up as a paratrooper in the Korean war. When he was discharged, Jimmy got a demolition job at the Brooklyn Navy Yard, at which he worked for twenty years. He joined the Demolition Steel Workers Union, eventually serving as their



business agent for twelve years. In fact, Jimmy turned the union's finances around, the books going from red to black during his term. Jimmy always showed he cared for his union brothers, helping guys who were down on their luck, out of his own pocket, if he had to. Every Thanksgiving he made sure the families of each union man who was not working still had turkey and the trimmings! He was a tough, generous man.


1980, following In his son Pasquale(Pat), who was trying out for the Dodgers, Jimmy moved to California. That was when he joined Local 44. It should be said here that, like your typical Italian guy from Brooklyn, Jimmy was a diehard baseball fan. Earlier in his life, he himself had tried out with the St. Louis Cardinals. To complete the picture of a true baseball family, his other son. Rocco was invited to play in the San Fransisco Giant Organization . What was baseball's loss turned out to be Local 44's gain, as Jimmy and both his sons became respected members.

I have some vivid memories of my years working with Jimmy and I'll just share some stories with you. One time when he was working on the 'A-Team', the producer offered Jimmy the opportunity to star as a regular on the hit TV series. But Jimmy turned him down--a chance many people only dream about. I can only admire Jimmy for knowing himself as well as he did to have the self-confidence to make that decision. He knew who he was--and who he wasn't. Then I remember the time when his son, Pasquale (Pat), was leadman and Jimmy was on the crew, he said, "You may be the leadman from 6 to 6 on this production, but I'm always your father and that's forever"

Another time, when he and I were asked if we would like to be extras in a police lineup scene, Jimmy announced to the world at large, "We don't do lineups!" Jimmy was a leadman and damn good at it and he wanted everybody to know it. Everybody got a laugh out of that! But at the same time, everybody also got the message that Jimmy knew his job was important and he was not interested in fame or the glamourous life. Jimmy respected himself--and for that, you had to respect him also. That was Jimmy, always making people laugh, sometimes not even with what he said, but how he said it, in that unmistakable Brooklyn-Italian accent! And at the same time, he was teaching them a life lesson. One time while we were working on a hip-hop program with a four walls set instead of the usual three, I said, "Hey, I can hang a picture of Coolio on the wall!" Jimmy's reply was, "Sure, you can hang a picture of 'culo' on the wall." I burst out laughing and so did everybody else--even though most of the people on the set didn't get the joke. It was just pure, infectious laughter--the kind that's good for your mental health! Jimmy's message? Don't take yourself too seriously! Jimmy was both an entertainer and a teacher!


And one last Jimmy baseball story that pretty much sums up what the man was about:

He enjoyed 18 years of retirement in San Diego with his late wife (of over 50 years), my mom, Liz Gebler who passed away 2 years ago.


He is survived by 2 brothers, myself (Ellen Rose) and my husband Eric and his grandson, Max.

tools and cameras through NASA that had literally been used in space. I was responsible for designing and creating a tether that would hook onto a Chinese rocket in order to dismantle it mid-flight and was also asked to create a zero gravity water sphere. What I did was mix KY Jelly with water to produce a clear resin ball. The ball was then used to represent water that could be held in the palm of your hand."

Retirement came early for Goble due to a torn rotator cuff from a slip and fall. On September 1, 1999, Goble retired from the only career he ever knew. Since leaving active membership, Goble continues to maintain a relationship with his fellow brothers and sisters through retiree events and enjoys puppy time at his local dog park.
