# **Business Agent's Report**

## Film Works L.A.

Film L.A. recently launched an outreach and education campaign aimed at the residents of the greater Los Angeles area. This campaign is focused on the overall value film, television and commercial production has to every person who lives within the Los Angeles area. Too often your neighbors take for granted the fiscal impact our industry has on the foundation of their lives, and obviously yours. This campaign, along with its partners, many of which are names you will recognize, and with the support of Local 44, will help to educate and engage the entire Los Angeles community.

With the usage of various forms of messaging like billboards, bus benches, production trucks, print, radio advertising, movie theater PSAs (Public Service Announcements), and the Film Works L.A. website, the message will be clear:

# Los Angeles needs us, and so does California!

With the recent news about various states throughout the U.S. reevaluating their Tax Incentive programs, and the effect they have on state budgets, we have all the more reason to be supportive of this program.

New Mexico's governor has recently called for a cut in the state's film tax incentive program from the current 25% to 15%, which would bring it below California levels, making California and Los Angeles even more attractive to productions looking for

savings. Similar reviews are taking place in Ohio, Iowa and Massachusetts, all on the heels of reports that filming in L.A. had a significant gain in local location shooting of 15% in 2010 over the same period in 2009. Gains in television, commercial, and feature films were also noted. This year saw continued growth in reality television programming, which rose 47%. These numbers point out just how valuable organizing reality programming is. With the successful organizing of "The Biggest Loser" a clear message has been sent: when crews stick together as a solid unit, top to bottom, as did our forefathers, demanding representation and respect, success will follow. How many more union jobs are waiting out there in the "reality world"? Plenty, and we need to recapture that work.

# **Commercial Update**

The Local recently held a meeting with newly initiated Commercial members to address areas of concern within this portion of the industry. I want to thank those who attended and brought forward various ongoing issues with contract violations. As was discussed at this meeting, the recapturing of the rightful jobs and the labor force within this part of the industry was only the first step in righting the many wrongs in Commercials. Now that Local 44 does in fact represent this work force, the engaging and education of the employers is well underway. We have successfully begun addressing and correcting many of these violations. As with all areas of the industry that employ our membership, members should feel a connection to the Union and a feeling of confidentiality with your Representatives. If you are aware of contract violations, improper wage

payments or even violations of State or Federal labor codes, I urge you to pick up the phone and call us. Without this level of support from the membership, correcting violations is difficult, if not impossible. I applaud those of you who have engaged with our office and brought these issues to the forefront; we have made and will continue to make progress with your help. And for that I thank you.

# **Health Care Survey**

As I have been reporting to you over the last few months, we all should be aware that health care is, and still remains, at the top of the list of priorities for us all. The IATSE has engaged the Binder Company, a nationally recognized research firm, to assist in gathering information from the IA membership. They have completed a series of focus groups and are currently compiling the information received from those focus groups. All of you will receive a survey asking for your participation and input. Additionally there will be town hall style meetings during the year. All of this is intended to get your voices heard and your input. In the Newsreel from the 3rd quarter 2010 (the one with the Stop Sign) I reminded you how important it is to participate and be involved in this process; I am asking you again to do the same. When this information comes to you, please take the time to read it and get involved!

#### Rizzoli & Isles

TNT's newest Drama "Rizzoli & Isles" introduces a level of female crime fighting much along the lines of the 1980's television hit series "Cagney and Lacey." Detective Jane Rizzoli, known for her tough, gutsy, tomboyish demeanor, pairs up with good friend and medical examiner Maura Isles to solve some of Boston's most complex cases. The one-hour drama is based on the Rizzoli/Isles series of Novels by Tess Gerritsen and is a far cry from your typical police show.

Creating the perfect backdrop for all of the Rizzoli & Isle's crime drama is Construction Coordinator Joe Fama. General Foreman Sam Brinson, and their talented crew of 40-50 Union members. As a collaborative effort, this team built four permanent sets and 21 swing sets that meander across three stages of Paramount Studios; some of which include The Dirty Robber Bar and Restaurant, several crime scenes, a Boston P.D. Headquarters, and a Voodoo church. Coordinator Joe Fama describes the transformation of the Boston P.D. Headquarters. "Stage 4 has been quite versatile throughout Season 1. Through change-outs, we've managed to make the stage an entire three story building. On the first floor you have a lobby, entry area, and coffee shop. The second floor is an extensive police bullpen area made of brick skins which we acquired from Paramount Special Effects, and the third floor is a basement equipped with a crime lab, autopsy room, and coroner's office. It was challenging to put all of these elements into one stage but I think my crew did an outstanding job. You're only as good as your foreman and crew."

Another example of great craftsmanship is Jane's apartment set which, according to foreman Samuel Brinson, is an "older one bedroom Boston style apartment with a kitchen, living room, and a tremendous amount of eastern flavor." Responsible for infusing the star's apartment with an elaborate personal touch is Set Decorator Leslie Morales. With the combined help of some of the industries greatest Property persons, Decorator Morales and Leadman Dan DuPont lead their crew in dressing the set

with detailed lighting, an extensive color palette made up of plums, navies, aqua, and roses, and a definite "Tom Boy" touch. Leslie Morales tells, "It's important to enhance a set with art that speaks to the character. So, since our character is a sporty gal, we dressed her apartment with sports paraphernalia consisting of an Eastern sports line and added a little bit of her childhood to the set by displaying a bottle collection she had accumulated throughout the years. The fact that I'm very familiar with the look of an eastern seaboard town

and have a knack for art, I was able to create the atmosphere of Boston with very little trouble. One challenge I faced was finding the right fabric for my drapes. My hero, Bobby Key, eliminated this concern by using his creative freedom to upholster a beautiful set of drapes. This really elevated the look of the set."

Due to "Rizzoli & Isles" being a crime fighter based series, most of the set dressing and props have uniformity in the sense that they revolve around the look and feel of a

We did see a revitalization of projects and work for our members putting employment numbers over 80% for the majority of 2010 and we look forward to these numbers increasing in 2011.

As your Secretary-Treasurer, I am always looking to improve services and communications to our membership. With that in mind, here are some recent instrumental improvements. Also included are proactive changes that will be accomplished before the end of our summer season.

Have you missed Local 44 meetings or events? Haven't received Local 44 flyers or emails with important information? All that information was available on Local 44's website and had been sent to you via email (if you are registered with the site). If you are still waiting for your postal carrier to get information the "traditional" way, why don't you take a moment, if you haven't already, and register with the Local 44 website at www.local44.org. Checking the Homepage at least once per week is the best way to take an active role in keeping up-to-date on all the important meetings, events, services, and information relevant to members in good standing. It only takes a few minutes to check through the homepage, so why not?

Also, be certain that the Callboard shows you are opted-in to receive emails from Local 44.

Looking for work? You can post your resume on the Local 44 Website (www.local44.org). Resumes have been available on the website for quite some time. Before the close of this quarter, resumes will be part of your personal Website profile. This will allow members in good standing to post their resumes on the website and edit existing resumes without having to re-submit a new resume. As with any online resume service, resumes are completely open to the public, so be careful about including personal information. Additionally, Local 44 will be buying advertising space in trade magazines in the near future to let hiring professionals know where they can find the best talent for their production. Get on board: update your resume, and be sure to post it on www.local.44.org.

Cant' find something at www.local44.org? Once you have logged on, head over to the upper-right section of your screen and type whatever you are looking for in the "Search" box, press enter and you will be shown all the articles that contain the criteria you entered.

Future services will include our Email/Web subscriptions to Local 44's Newsreel Magazine. When members elect to receive issues of Newsreel electronically, our Union will save on printing and postage costs, and in the process help our planet by cutting back on paper waste. Delivery may be either emailed PDF files or notifications that the latest copy is available on Local 44's website.

Phase 2 of the website development is underway. Soon we will be able to update our own membership information online. We will be able to update our mailing address and contact information, check our membership status, change our work status, and more. It's all coming in 2011!

# **President's Report**

The holidays have come and gone and we begin our new year with the hope of being able to maintain our employment percentages of last year. There was an upswing in work due to the incentive package put forth by the state and local government and hopefully, from what I have been reading, many states are talking of giving up or reducing their incentive programs. That certainly may help to keep more production home. There have been some positives that happened during the later part of last year. One of those was the negotiated contract with HBO, Showtime, and Starz which, to most, was long overdue and I would personally like to thank International President Matt Loeb, Vice President Mike Miller and all serving parties involved on what I feel was a job well done. I hope the membership feels the same. The other positives are that SAG and AFTRA settled along with the DGA in their contract negotiations and we finally, after 23 years or more, were able to align ourselves with the Teamsters and other Basic Crafts to negotiate in our next contract negotiation. Thanks again to President Loeb for his foresight in seeing that we must all stand united in order to


have a chance at a decent contract agreement in the future.

These are some of the positives, but one negative that has been circulating for some time is the effect of Digital Piracy in our industry. We all must take a serious look and do our best individually to not support or tolerate this theft and let others know that it is literally stealing from not only the producers but from the pensions and welfare of all of us that work in the industry. These are some of the movies that were downloaded or sold on the streets that took away from the contributions to your health and welfare. Avatar -16,580,000 copies, Inception -9,490,000, Kickass-11,400,000, Shutter Island -9,490,000, Ironman II-8,810,000 and the list goes on. These numbers were gathered by six MBA students of SP Jain Institute of Business Management that said rippling effects of piracy lost output for United States industries of 20.5 billion dollars per year and thwarts the creation of about 140,000 jobs and accounts for more than 800 million in lost tax revenue. More importantly, there is the loss of contributions to our health and pension plans that do not get contributed to from the loss in residual which I have not been able to get an exact amount on yet, so we must all be vigilant and aware of this conduct and try to put a stop to it now or we will really begin to feel the results of this if we have not already. To many, it seems quite innocent to take or download material from the internet such as movies or music, but what happens is we take the health and pensions that many have worked so hard for. So, let us start by educating our youth and anyone else we know to not engage in this conduct until the Producer and government authorities come up with a better solution. There is a government organization called ICE which stands for Immigration and Customs Enforcement and they have cracked down on many of these sites and if you know of any of these sites, you can contact them by going to their website at <a href="https://www.ice.gov">www.ice.gov</a>. The IA has also been very proactive on the fight of Digital Theft, so let us do what we can to fight piracy.

One last thought I would like to add is: when it is slow out there, we have some members that work for non-union set shops and seem to think this is alright because they already have their hours in for their benefits, but I say, if you choose to do this at least call your Business Agent and let Ed Brown and his staff know or myself so that we can organize these shops. This would then benefit you as well as all of the members because they could be contributing to your health and pension. If not, you contribute to enticing more of these shops to be used by producers and less contributions to our plans which we already have enough of from runaway productions. So please keep us informed of any of this activity and thank you for allowing me to serve our Local.

# IATSE GAINS WEIGHT WITH THE BIGGEST LOSER

On November 8, 2010, the crew of "The Biggest Loser" voted unanimously to walk out because the producers declined to sign an IATSE contract that paid full health and pension benefits.

The crew walked out together.

Over the next two weeks, the crew demonstrated great unity and strength, walking pickets lines at the principal production location. No crew member who walked out crossed the picket lines to go back to work.

Hollywood IATSE locals had the crew's backs. The strikers also drew support from union people all over L.A. County and California.

On Monday, November 22, the crew unanimously ratified an IATSE-negotiated agreement.

The victory of "The Biggest Loser" crew and the IATSE sends a loud message to other non-IA reality show producers: treat your crews with respect and produce your shows union!

Morales and her team have done an excellent job of putting their own spin on what could have been a monotonous look, and Property Master Jared Scardina and his assistants Oliver Doering and Paul Baker have delivered when it comes to supplying detectives Rizzoli and Isles with all of the officer accessories, badges, handcuffs, glocks, and such. According to Doering, "Every morning we'd review the script and go over every scene for the day to ensure that every element would be fully taken care of. What was so fascinating about 'Rizzoli & Isles' is that every day was an adventure and a learning experience. One morning we'd be in the autopsy room equipping the actors with tools, gloves, dummies, and blood and that afternoon, we'd transition to a serious wedding scene with a whole other array of props. The variation in scenes was quite enjoyable and it's a pleasure to work with Property Master Jared Scardina; he's always on top of things."

Enhancing the action behind the concept

of crime fighting were Paramount Special Effects persons Tom Mertz and John Peyser. With their combined experience of 38 years, there was nothing this duo couldn't pull off. Together the two were responsible for all of the bullet hits on actors, shoot-outs involving cars and buildings, blood splatter, atmospheric effects, fire scenes, and replicating the aftermath of crime scenes. # What is a "Member in Good Standing"?

As the Entertainment Industry constantly redefines itself, the challenges of finding work increase. Now more than ever, it is important that Local 44 members who are current with their dues and in good standing are afforded ALL the rights and privileges stated in our Constitution and By-Laws. Gone are the days when the Union turned a blind eye to persons NOT in good standing taking union work and employment away from members with their dues paid who wait at home for the phone to ring.

For years, our membership believed that "good standing" meant paying your dues before the start of the next quarter and not getting suspended. According to our Union's Constitution and By-Laws, this is not true. Any initiation fee, dues, or assessments must be paid in full by their respective due dates or that member loses his/her good standing and becomes delinquent until payment is made (all dues payments are to be accepted by Local 44 prior to the close of business on the first day of January, April, July, and October). A delinquent member becomes suspended when he/she continues to be delinquent into the following quarter (90+ days late). Why is this important? Like persons who are suspended and dropped, delinquent members lose their good standing status and forfeit their rights and privileges. For example; delinquent members are not entitled to: attend/participate in Local 44 meetings and events, a vote on each question at meetings, a vote on each question designated for membership issues (contracts, elections, motions at meetings, etc.), run for Local 44 office, keep their place on the out of work list housed in the Callboard, hold employment under Local 44's contractual jurisdictions. What does all this mean? Our Constitution and By-Laws is our rule book and guide that assists the day to day union operations. Practices of past administrations or misinformed theories that have perpetuated for decades do not relieve us of what the actual rules are.
