IATSE Local 44 Constitution and By-Laws, Article VI, Sec. 5 ¶ A:

All Local 44 officers, Executive Board members, and committee members must be members in good standing for at least two consecutive years before the final business day in January before the election. All Local 44 officers, members, and delegates, must be eligible for his or her specific office or position according to the provisions of the International Constitution and By-Laws and Local 44's Constitution and By-Laws.



# **NOTICE OF ELECTION**

In conformance with its Constitution & By-Laws, as well as the Labor Management Reporting and Disclosure Act of 1959, and the Constitution of the IATSE, notice is hereby given that Affiliated Property Craftspersons, Local 44, IATSE, will be conducting its triennial election for officers during the months of March and April, 2013. Pursuant to Article IX of the Local's Constitution & Bylaws, the election process will be overseen by the Local 44 Election Committee.

The offices subject to this election are: President, Vice-President, Business Agent, Secretary-Treasurer, Sergeant-At-Arms, two (2) Representatives each from four (4) Crafts (Coordinators, Prop Masters, Set Decorators, and Special Effects), and three (3) Representatives each from the other Crafts (Property and Propmaker). Additionally, there are three (3) Trustee positions and one (1) Delegate for Conventions of the IATSE from each of the six (6) Crafts that are subject to the election. Those elected to the offices of President, Secretary-Treasurer and Business Agent serve as delegates to Conventions of the IATSE by virtue of their office.

There are also twelve (12) Alternate positions open in this election. There is an Alternate for each of the six (6) Craft Executive Board Representative categories, and six (6) Alternate Delegate positions for each of the six (6) Craft Delegate positions.

The Election Committee is in charge of finding an Election Service Provider, securing a post office box for return ballots, and working with the Balloting Service to prepare, send, retrieve, and count the ballots. The Committee also generally administers the election process and coordinates the mailing of literature from candidates to the membership. Pursuant to Article IX, Sections 2 & 8, of the Local's Constitution & By-Laws, the Election Committee is the sole

body within Local 44 that may receive and rule upon any objections, challenges or protests that arise throughout the election or that are filed after the ballots are tabulated.

The primary election ballots will be mailed by March 15, 2013, and must be received (not postmarked) in the secured post office box selected by the Election Committee no later than 9:00 a.m. on April 1, 2013. The ballots will be sent to the membership by the Election Service Provider; a separate instruction sheet, as well as a self-addressed stamped envelope, will be included with the ballots.

The Election Committee shall oversee the counting of the ballots by the Election Service Provider and each candidate may have three (3) members in good standing of the Local designated as his/her observer to be present at the ballot count.

If no candidate wins election outright in the primary for a contested office—they must receive 50% plus one vote of all qualified votes cast—then there will be a run-off round for those contested positions. The top vote-getters in each primary contest are in the run-off (again, only in the event that a candidate does not receive 50% plus one vote of all qualified votes cast). If there is only 1 spot available (such as Business Agent, Secretary-Treasurer, President, etc.) and no candidate receives 50% plus one vote, then the two (2) candidates with the highest vote totals will compete in the run-off election.

In the event that no more candidates than open offices are nominated, then the candidates so nominated are deemed elected. For example: if only one candidate is nominated for the office of Vice-President, that candidate is automatically deemed elected as the Local's Vice-President for the next term of office per Article IX, Section 4,

of the Local's Constitution and By-Laws.

However, if there is more than 1 position at stake (e.g., three Property Person Executive Board positions) then any candidate receiving 50% plus one vote in the primary election shall be declared elected; any remaining office(s) where no candidate received 50% plus one vote shall be subject to the run-off election. In such an event, then the candidates in the run-off are the candidates with next highest vote totals, plus one. For example: in an election for three Property Person Executive Board seats, if only two candidates achieve 50% plus one vote, the next two candidates with the highest vote totals are then in the run-off election for the one remaining Property Person Executive Board seat.

Ballots for a run-off election will be mailed on or before Wednesday, April 10, 2013, or the closest business day thereto, and must be received at the post office no later than 9:00am on April 30, 2013. If a run-off for any elected office is required, these ballots will also be sent to the membership by the Election Service Provider; a separate instruction sheet, along with a self-addressed stamped envelope, will be included with the ballots. Any candidate in the run-off election shall also have the right to appoint an observer, who must be a member in good standing, to be present at the ballot count.

A special Executive Board meeting will be called on June 5, 2013, to install all elected officials whether they won in the primary or the run-off elections.

Please consult Article IX of Local 44's Constitution and By-Laws for additional information about the election process. Copies of the Constitution and By-Laws are available at the Local's Business Office.

# **ELECTION COMMITTEE CERTIFICATION**


# **JEANNIE GUNN (inc.)**
