FROM THE DESK OF THE BUSINESS AGENT

California Tax Credit Program

It has been a very busy few months as we prepare for the 2014 Legislative session in Sacramento. Since 2009 when the Legislature enacted the California Film and TV Tax Credit Program, we have seen its positive affect on the creation of jobs. And that has all been good news, however as we crawl along with a successful yet limited program, other states are sprinting past California at lightening speed. This needs to change and 2014 needs to be our time to make that change a reality. As I have stated over and over, reaching the goal of increasing California's program is my highest priority. After returning from International Convention I participated on the Charter Network's California channel along with the Executive Director of the California Film Commission Amy Lemisch in a two person panel moderated by former state Assemblyman Anthony Portantino expressing the need to enrich the state's program. The following day I attended a meeting in San Francisco at City Hall with various northern California Film Commissioners, the Mayors Communications and Public Affairs Representative, Bay area business leaders, Hotel Counsel and numerous vendors associated with the industry. As history has told us, opposition to the incentive has come from areas in the north end of the state. This is why it is imperative to take our plight directly to that area, building support as we go. A few days later I attended a Film California First event. I have continued to participate in numerous meetings with industry Labor Unions and Guilds throughout the state. Most recently I traveled to Sacramento again to meet with Sacramento and surrounding areas Film Commissioners as well as various lobbyists who represent a broad range of industry realms. Yes I have been busy and intend on continuing these efforts, bringing your voices to all that will hear it. We have now reached a time when everyone needs to be engaged.

If you have not signed up to be a part of the Local 44 California Entertainment Jobs Committee, then you need to. You can do so by simply going to the Local 44 website home page and follow the prompts. We have reached a point where not only does every member need to be involved but the Local as a whole needs to be fully invested, both emotionally and financially, for this program to succeed. This success relies on hard work and relationship building throughout the state. I have made a commitment to you that I will make this my highest priority, and I have. Working around the clock as I believe you would want me to. Let's face it, we are in the fight of our careers, a fight simply to survive and to prosper. Our industry can't go the way of Boeing or the auto industry, but if we don't completely invest, we are surely heading in that direction. Don't misunderstand, the industry will still exist in California, it just won't be the robust version we have all come to count on. Network TV and major Films are no longer part of our landscape and it most likely will stay that way unless we invest in this fight. Other labor Unions around the nation have routinely supported actions to maintain their very successful programs. They do this through member actions and financial investments. Investments in lobbying and engaging in the political process. It is the way things get done, just plain and simple, and we need to follow those leads that have shown that success, just about everything depends on it.

It's either all in, or all done!

IATSE 67th Quadrennial Convention

This past July the International conducted the 67th Quadrennial Convention in Boston. As stipulated in the International Constitution, conventions occur every four years. Local 44 was well represented amongst a gathering of Delegates numbering approximately 800 from both the United States and Canada. This week long event was jammed packed with activities. The theme of the convention was built on the four pillars of success at the direction of President Loeb. These pillars, Leadership, Skills & Safety, Activism and Communication were the cornerstones of the week. The complete and total energy throughout the vast room of Delegates was truly amazing. Democracy was shown at its best, and the overall strength of unity ran through the veins of all in attendance. If it seems that I am jacked up from

the experience, that's because I am. After my long career and membership in the IA to witness first hand a truly professional organization where every voice is heard, every opinion has value and the flow of one united gathering of minds and spirits is awe inspiring. While I was in Boston my office received a call from one of our members whose opinion was that the Locals attendance at convention was a complete waste of the Locals time and resources. Firstly every major Labor organization in the world holds a convention of this type. So this is not some rare occurrence, it is the norm. If your Local Union does not participate, then you as a member will be disconnected from the workings of the International and your Representatives who you elect will not have the information or knowledge of the organization to share with you. Attendance gives a rare opportunity for your leaders and Delegates to interface with other Union Delegates across two countries. It provides a chance for every Local to exchange individual successes and challenges within those Locals geographic jurisdiction. It builds brother and sister relationships that more times than not are informative and useful. As we all know our portion of the industry has spread across the nation and the globe, and many members find themselves working outside of Hollywood and in the jurisdiction of another IA Local. The bonds that are built at these conventions have proven over and over to be a valuable resource to our members working elsewhere.

Each of your elected Delegates participated in their own assigned Committees, such as Finance, Constitution, Resolutions, Legislative just to name a few. Committee meetings in some cases were lengthy and Delegates were required to meet several times, meetings where held in the evenings throughout the week with final Committee reports provided towards the culmination of convention. In addition Delegates participated in many Educational training sessions, built on the four pillars of success; these courses covered Activism, Craft Skills and Safety Training, Communications and Leadership Development. So if you are someone who thinks conventions have no value, I encourage you to take the time to speak to your crafts elected Delegate and ask questions about their experience, I think it will be an informative and enlightening

FROM THE DESK OF THE SECRETARY-TREASURER

"Now more than ever"

Los Angeles is buzzing with the Television season back in full swing. Your Callboard has been filling full rate call requests for Propmakers, Property, Floor Covers, Drapers, and Greens.

What weighs heavy on all of our minds is the lack of Full Rate Feature Films in Los Angeles. We continue to see other states and countries offer lucrative film incentives, as much as .40 cents back on every producer dollar spent luring our industry away. Now more than ever, we need to make our stand.

Because Los Angeles hires do not trigger a particular State's "local hire" requirements to get producers' their full return on that state's film credit, our members do not always travel to these incentive-rich states under our Basic Agreement. Many of us have heard of or know brothers and sisters who have moved to incentive states so they can be employed as "local hires."

Some of those Hollywood IA members remaining at home face working on lower tier productions making less hourly wages. Nobody likes making less money per hour. The common statement amongst those members is "at least I am getting qualified hours for my medical benefits." In these difficult times, imagine if these low tier productions were non-union. Non-union HBO is a not too distant past. Members were making the lowest rates producers would pay with out union benefits.

It is no secret that the entertainment business model has changed dramatically. Take a look at the trend of primetime network television programming and what is appearing these days at big-screen multiplex theaters. They are the result of the modern corporate Hollywood machine. It is ALL about money. This is where we are.

For years, our Hollywood Locals' leadership and members have heard California legislators stagger through the dilemma of a statewide deficit while trying to figure out where tax dollars need to go; public schools, state run facilities and agencies, utilities, infrastructure, etc. Our cash strapped state sometimes views our Hollywood Entertainment Industry as "doing just fine." For this reason our Union started the California Entertainment Jobs Committee, made of Local 44 members, to keep our legislators focused on a workforce and industry that, WHEN WORKING, contributes greatly to the Los Angeles and California economy! Through this committee's efforts, the film incentive program was renewed for an additional two years. Although every California incentive dollar helps, it is not enough to overcome the massive amount of incentives offered by other states. For example, there are states that offer incentives of \$250 - \$500 million annually just for filming in their respective states. That does not include grants that can be offered for particular productions in

addition to the state's film credit. Those are tough numbers to compete against.

For this regional crisis, our California IA leadership has enacted a plan to engage Sacramento lawmakers head on. This plan includes firming up relationships with industry Unions and Guilds plus public sector Unions, hiring a professional firm to lobby on behalf of our IA membership, educating the public and lawmakers of our industry's importance to the state of California, and mobilizing our own members. This is where we are going. Stay tuned CEJC members (and those L44 members who have not signed up yet), there will be plenty to do in the coming months.

IATSE's 67th Quadrennial Convention

Congratulations to International President Loeb and the IA Leadership for a very successful convention focused on Leadership, Skills and Safety, Activism and Communication. Plus, I send a personal congratulations to Local 44's veteran delegates and also the newly elected delegates who performed fantastically at their first District and International Convention. Our Local's delegation was featured several times during committee assignments and debate from the convention floor. Good work to everyone!

At the close of the convention ceremonies, our own Carl Hicks received the International President's award for his service and dedication to the IATSE and Local 44 membership. It was a very proud moment for Carl and for Local 44, since one of our own has not received this honor for over a dozen years.

It truly reflects how far we have come as an organization over the past several years!

THE LEGENDARY CHUCK HATCHER RETIRES

Son of Charles and Mary Hatcher, Brother Chuck Hatcher was born and raised right here in Los Angeles on November 18, 1956. Fresh out of high school Hatcher enrolled as a full time college student at LA Trade Tech, where he dove head first into a carpentry education. In the spring of 1976, Universal Studios reached out to LA Trade Tech looking for qualified individuals who possessed outstanding carpentry skills. The school referred Hatcher for this position. Hatcher faced a pivotal career decision: should he continue with his carpentry education and become an instructor for the college or pursue a future working for the studios? When presented with his application for employment Hatcher discovered that Universal was so eager for him to begin work that they had already filled it out with all of his information. Hatcher's first job was on the feature McAurthur where he acquired his days to join the Local 44. Hatcher recalls being transported by van to the Union Hall in 1976 where he paid \$400.00 to join as a Propmaker.

Chuck became a permanent fixture at Universal and found himself bouncing around with an abundance of work and overtime, and quickly worked his way up to the Forman

rate. He acted as the Location Forman on such productions as *Blues Brothers* and *Knight Rider* and went on to perform his first Universal rebuild. According to Hatcher he learned a very valuable lesson during this period in his life, "respect the older fellas in the business, and to practice chivalry toward those who help you climb the ranks."

Shortly after his time on the backlot rebuild, Hatcher had a life altering work place injury. While at Universal Studios repairing one of the large stage doors, Chuck's scissor lift malfunctioned and a steel beam broke his neck. He was rushed to Cedars Sinai where he underwent intense surgeries very similar to those performed on Christopher Reeves. For one full year following his accident. Hatcher remained in the care of Cedars Sinai due to a severe neurological condition causing a form of neurological palsy. Doctors told Hatcher that he would never return to his former line of work yet after extensive rehabilitation Hatcher proved his doctors wrong. Apparently, this near death experience is how his friends derived his nickname, "The Legendary Chuck Hatcher".

Chuck came back into the industry and contributed to such productions as *Frazier*, *Star Trek*, *Becker*, *JAG*, and *NCIS*. For ten

years, Chuck served as Local 44's Universal Shop Steward. In 2006, he acquired his Coordinator card and by 2008, he was running yet another Universal backlot rebuild. Hatcher thanked the Lord for the opportunity to lead the massive rebuild due to the lull in work that the industry was facing because of the writers strike. Through the Phoenix Project, Hatcher was able to provide work to nearly forty Union members. As Universal's Forman of Facility Operations, Hatcher used his talent to rebuild stage doors, and to remodel the camera department and Block 7's Modern New York Street.

After 34 years in the business and every paycheck stub to prove it, Hatcher decided to call it quits. On June 1, 2013, brother Hatcher retired. He now spends his days with his loving wife of 14 years, Stephanie. When asked what he thinks about retirement so far he explained, "For so long I would either have the money but no time, or the time but no money, but now it's great, I've got both. I now take care of our 500 pigeon ranch and have time to restore old cars and Harley's in the wood shop I built for myself; life is good." As Hatcher experiences each day of his retirement thankful to have lived to enjoy it, Local 44 wishes him and his wife continued good health and happiness in the years to come.

discussion. There were many highlights throughout the week. The convention was addressed by Massachusetts State Senator Elizabeth Warren, former Secretary of Labor Hilda Solis, President of the DGA Paris Barclay, Paula Peinovich President of the National Labor College, Nick Wyman President of Actors Equity among others, including a video presentation by Richard L. Trumka President of the AFL-CIO. The week was culminated by the unanimous reelection of International President Matthew D. Loeb and the Internationals Executive Board. There were no uprisings, no demonstrations, and no disruptions.
