VOTER INFORMATION GUIDE

Dear Fellow Brothers and Sisters of Local 44,

Your Election Committee

With the election just around the corner, we in the Election Committee would like to convey a few thoughts to the membership to address some concerns which have been brought to our attention.

Firstly, there have been questions concerning the time frame restrictions placed on the balloting process, that it is too short and too dependent on the postal service to ensure that every vote is received by the third party election processor in time to be counted. Everyone must understand that this election, just as prior elections, is strictly bound to follow Section IX of the Constitution & Bylaws. Therefore the ballots must be mailed on March 15, 2019 and be returned no later than April 1, 2019 at 9am in order to be counted. The box will then be emptied on April 1, 2019 and transported under the supervision of your Election Committee members to the soundstage at Local 80 to be counted. Any ballots received on or after that day cannot be counted as the P.O. box will no longer be checked. This is all done to ensure the integrity of the election process and that all ballots are received and properly counted in accordance with the Constitution & Bylaws, to which ALL members are bound.

In addition, all members should take note that April 1, 2019 falls on a Monday, so ballots will really need to be received in the Election PO Box by end of day March 30, 2019. This is CRITICAL!

We on the Election Committee are truly honored to be part of this process on behalf of our Brothers and Sisters. The responsibility to have one's vote counted is a duty shared equally by every member, and the strength of our union is increased by each VOTING member. To that point, WATCH YOUR MAIL starting March 16, 2019. It's a Saturday. If your Union Leadership is important to you, and if you're reading this Newsreel we can assume that it is, then PRIORITIZE that envelope when you get it. Stop what you're doing, open it, TAKE THE TIME to fill out your ballot, seal it in the postage paid envelope and put it back in the mail! DO IT THAT DAY, then it will be in the P.O. box with plenty of time to spare. You will have fulfilled your duty, and spoken your peace. Congratulate yourself!

In such an event, then the candidates in the run-off are the candidates with next highest vote totals, plus one. For example: in an election for three Property Person Executive Board seats, if only two candidates achieve 50% plus one vote, the next two candidates with the highest vote totals are then in the run-off election for the one remaining other Crafts (Property and Propmaker). have three (3) members in good standing Property Person Executive Board seat.
